

**ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY

I understand that the risk of becoming exposed to or infected by Coronavirus/Covid-19 at the office of Marino and Associates may result from the actions, omissions, or negligence of myself and others, including, but not limited to, employees of Marino and Associates and other clients of Marino and Associates.


I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection to my working with or coming to the offices of Marino and Associates.

On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless Marino and Associates, and employees, agents, and representatives, of and from the all claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand that I do not need to sign this, and can request any personal papers be returned to me.
