Forms must be **legible.** We recommend that you type the information, and then save, print, sign and fax the form. Failure to respond by **September 30, 2017** will result in the termination of your DDE User ID. If your DDE User ID is terminated, you will need to apply for a

new ID by completing the Online Inquiry Service form FDF. The normal processing time to receive a new user ID is 20 business days.

#### **Streamlining Level of Care Processes:**

Department for Medicaid Services (DMS) and Deloitte are designing a system to streamline the Level of Care process. The system design should be finalized by 6/30/17, Development completed by 7/30/17 and testing will begin on 8/21/17. The scheduled "Go Live" date is 10/1/17. As of 10/1/17, Carewise will no longer accept Level of Care (MAP-726A) via fax. Between 8/21/17 and 9/28/17, DMS and Deloitte will provide half day trainings for the new Level of Care process.
