### **Targeted Probe and Educate (TPE):**

The Centers for Medicare & Medicaid Services (CMS) utilizes Medicare Administrative Contractors (MAC) to review clinical documentation in order to prevent improper payments. In 2014 CMS began a program that combined a review of a sample of claims with education to help reduce errors in the claims submission process. CMS called this medical review strategy, Probe and Educate.

<u>Changes to Accessing Fiscal Intermediary Standard System (FISS) Direct Data</u>
<u>Entry (DDE)</u> – A change has been made to the CMS HPES Enterprise Data Center sign-in screen when accessing FISS DDE. The screen is now titled, **CMS DXC Virtual Data Center**, and the "5 HP TPX" selection has been removed. To access FISS DDE, you now need to select "2 DXC-VDC Menu".

#### Survey & Certification- Emergency Preparedness Regulation Guidance

On September 8, 2016 the Federal Register posted the final rule *Emergency Preparedness Requirements for Medicare and Medicaid Participating Providers and Suppliers*. The regulation went into effect on November 16, 2016. Health care providers and suppliers affected by this rule must comply and implement all regulations one year after the effective date, **November 16, 2017**.

#### New Medicare Card (formerly called SSNRI):

CMS is removing Social Security Numbers from Medicare cards to help fight identity theft and safeguard taxpayer dollars. You must be ready by April 2018 for the change from the Social Security Number based Health Insurance Claim Number to the randomly generated Medicare Beneficiary Identifier (the new Medicare number). Up to now, we referred to this work as the Social Security Number Removal Initiative (SSNRI). Moving forward, we will refer to this project as the New Medicare Card.
